
AMH 241 American History I

- 2. The effect of the geography of the continent on the development of America
- 3. The on-going encounters among European, African and American Indian cultures.
- 4. The role of religion in American life in relation to spiritual awakenings, denominational diversity, reform movements, and family life from earliest time through the Civil War.
- 5. The forging of American nationalism from the Revolutionary Era through Reconstruction.
- 6. The rise of democratic politics and the emergence of a mass party system from the Federalist Period through the Jacksonian Era.
- 7. The transformation of American society from rural agriculture to urban industrial culture.
- 8. The emerging crises of slavery and sectionalism culminating in the Civil War and Reconstruction.


